Today those dikes have such a profound influence on our culture, economy and geography. And, of course, habitat for birds. # SKAGIT AUDUBON APRIL CONSERVATION REPORT By TIM MANNS, CONSERVATION CHAIR

When this issue of the *Flyer* appears, the Washington State Legislative session will have about 3 weeks to go, with the finish scheduled for April 26. On Audubon Advocacy Day (February 18) and throughout the session, Audubon Washington staff and chapter volunteers have been focusing on 3 legislative priorities: Governor Inslee's bill to levy a carbon tax on the state's largest emitters and to establish a carbon cap-and-trade system; a bill to improve the safety of oil transport by rail and on marine waters; and improving knowledge and management of the forage fish which are so important to declining marine birds. At this writing in the third week of March, all 3 bills are still in play.

Particularly on the carbon and oil bills, Audubon Washington is working closely with Sound Action and the Environmental Priorities Coalition.

Here in Skagit County and nearby, your Audubon chapter has weighed in on a variety of issues since the last *Flyer*. Washington Department of Fish & Wildlife (WDFW) is embarking on projects at Leque Island near Stanwood and at Fir Island Farms/Hayton Snow Goose Reserve to restore estuary habitat important to salmon and other species but largely lost around Puget Sound. We support these projects because habitat restoration is part of Audubon's mission. At the same time, we look for ways to ensure that varied bird habitat is considered and, where possible, enhanced, and that the importance of access for wildlife watching (e.g. birding) is recognized and facilitated.

Skagit Audubon communicated with Washington State Parks about an unpublicized plan for forest thinning in Deception Pass and Dugualla State Parks. The agency is modifying its approach to provide public information about the perceived need for this project and give an opportunity for public input.

The appeal of Skagit County Planning & Development's determination that Shell's Crude-by-Rail East Gate project at March Point does not require a full environmental review was successful. The early March announcement of the County Hearing Examiner's decision was followed a bit later by Shell's announcement that it would in turn appeal, and then that it is suing both the Hearing Examiner and Skagit County over the Examiner's decision. Skagit Audubon has commented at every stage in the lengthy permitting for this project with an emphasis on the need for a careful and complete analysis to determine what would constitute adequate and effective mitigation for possible environmental effects (on Padilla Bay National Estuarine Research Reserve, the giant March Point heronry, etc.) and potential impacts to human health and safety. The February hearing appeal happened even as a derailed oil train was burning in West Virginia followed by several more such derailments in the following weeks.

In late March, issues for Skagit Audubon have included opposing state legislation that would undercut WDFW's and Tribal collaborative work with local residents to manage elk-related problems in the Skagit Valley and Washington Department of Natural Resource's permitting of a timber harvest in an area of diverse wetlands and important habitat adjacent to Mount Vernon's Little Mountain Park.

#### !!! GOOD NEWS (So Far) REGARDING SAFE OIL TRANSPORT IN WASHINGTON STATE !!!

HB 1449, Oil Transport Bill, passed the State House floor vote March 5th! Jennifer Syrowitz, Washington State Audubon Chapter Conservation Manager, sends thanks to all who helped this happen. A few weeks ago I ran into our 40th District's Representative Jeff Morris (D) and was able to thank him personally for his part in passing this bill. Jeff Morris mentioned that the letters and other communications he receives from Washington State's Audubon Societies tend to be well thought out and meaningful. At this writing, the Oil Transport Bill is under consideration in the State Senate. – *Jackie Boss, Publications Chair, Skagit Audubon Society*

April's hikes will range from Puget Sound to the Chuckanuts. Unexpected circumstances such as unforeseen trail problems, weather, logging, construction or road conditions may cause cancellations or changes in the following hikes. Dogs are discouraged on Audubon-sponsored hikes. If dogs are on a hike, they must be on a leash at all times. All the hikes are on a Wednesday. # WED. – APRIL 1 – LOOKOUT MOUNTAIN PRESERVE

This trail is on the east side of Lookout Mountain

above Lake Whatcom. It opened in 2013. This basic

loop is 5.3 miles, which includes a side trail to a lookout. The elevation gain is 600 feet. Other options available include additional hiking above the Preserve and/or driving to and hiking the Stimpson Family Nature Preserve. The Preserve trailhead is located a mile or so south of the Stimpson Family Nature Reserve on the Lake Louise Road. Whatcom County hikers should drive directly to the trailhead. Other hikers meet at the Chuckanut Drive Park & Ride in Burlington at 8:30 a.m. These people will drive to the trailhead by way of the Alger-Caine Lake Road, the South Lake Whatcom Boulevard, and the Lake Louise Road. We will meet at the trailhead about 9 a.m. WTA bus service is available from Bellingham to the trailhead.

# WED. – APRIL 8 – WASHINGTON PARK, HEART LAKE, & LAKE ERIE

Terry Slotemaker, 360-293-6514, or his designee, will lead us on these two hikes scheduled in the spring to take advantage of wild flowers in bloom. Meet at 9 a.m. in **LOT A** at Washington Park in Anacortes. To get to Lot A, turn right just at the park entrance. The sign says "Picnic Area" with an arrow pointing to the right. A child's play area is close to this large parking lot. When you return to your car, you may leave for the Heart Lake hike. To get to Heart Lake, drive toward Anacortes from Washington Park. Turn right on D Avenue. Then turn left onto 32<sup>nd</sup> Street. Then turn right on H Avenue which will lead you to the Heart Lake Road and the parking lot.

#### WED. - APRIL 15 - WALLACE FALLS

This hike is through forest and near spectacular waterfalls north of Gold Bar along the Stevens Pass Highway. **Meet at 8 a.m.** in the S.E. corner of the Mt. Vernon Safeway parking lot. Seattle, Snohomish County. and Camano Island hikers can go directly to the trailhead. Car pool according to your chosen option.

OPTION 1: This seven mile loop to the top falls has a 1,400 ft. elevation gain; **Return time is 2** p.m.

**OPTION 2:** This is a 9.8 to 14 mile loop with a 1,800 f t. elevation gain to Wallace Lake. **Return time is 4:00 p.m.** 

A Washington State Discover Pass is required for parking at Wallace Falls State Park!

# WED. – APRIL 22 – PINE AND CEDAR LAKES & RAPTOR RIDGE

Hike to two very pleasant lakes in the Chuckanut Mountain area. This hike is up to 9.4 miles one way with shuttle cars returning hikers to the original trailhead. There is a 1,900 ft. total elevation gain. The 1.7 mile uphill route from the Pine/Cedar Trailhead is steep. The 5.4 mile down-hill route via the new Raptor Ridge Trail down to Lost Lake Trail which continues down to the North Chuckanut parking lot is less steep and will lead to Arroyo Park, the Interurban Trail, and finally the North Chuckanut parking lot. Meet at 9:00 a.m. at the North Chuckanut parking lot located off Chuckanut Drive just north of California Street at about milepost 18.5. At that time we will pool rides to the Pine/Cedar Lakes trailhead based on the time one wishes to arrive at the North Chuckanut parking lot at the end of the day. Some will need to be shuttle drivers back to the Pine/Cedar Lakes trailhead. First return to the North Chuckanut Trail head will be 2:30 p.m.; second return will be 3:00 p.m. Hikers may leave when they return to their cars except for those who will be involved in shuttling drivers back to the Pine/Cedar Lakes trailhead.

# WED. – APRIL 29 – HOYPUS POINT, HOYPUS HILL, & ALA SPIT

There are many hiking opportunities on Hoypus Point. To Ala Spit via the most direct trail route and back is 6.5 miles. Other trails can be added to increase the mileage for the day. This hike is selected on this day because there will be a low tide around 10 a.m. and hikers should be able to access the Spit. The Hoypus areas are in Deception Pass State Park. Meet at 9:00 a.m. at the trailhead at Cornet Bay in Deception Pass State Park. Cornet Bay has docking facilities and a rest room. You may leave when your carload is back to the trailhead. Most people return between 12 and 1 p.m.

A Washington State Discover Pass is required for your vehicle!

### WED. - MAY 6 - LOST LAKE TRAIL

Hike to a mirror lake in a rock trench on Chuckanut Mountain. Both options below will utilize a new trail. The Rock Trail was completed in 2014, connecting the Cyrus Gates Overlook with the Lost Lake Trail in the trench below. There are two

options:

**Option I** is a **STRENUOUS** 10 mile hike with an elevation gain of 2,400 feet. Meet at 8:30 a.m. at the Lost Lake parking lot (formerly known as the Clayton Beach lot) at the south end of Larrabee State Park off of Chuckanut Drive. Return time for this hike is 3 p.m.

**Option II** is a much less strenuous 7.2 mile hike with several hundred feet of elevation gain. Meet at 9 a.m. at the North Chuckanut parking lot

located on the east side of Chuckanut Drive between the Old Samish Highway and California Street. This is about milepost 18.5. Option II hikers will pool rides and drive to the Cyrus Gates Overlook where the hike will begin. Return time to the North Chuckanut parking lot will be 2 p.m. Drivers will need to be shuttled back to the Cyrus Gates Overlook. A Washington State Discover Pass is required for parking at both Larrabee State Park and the North Chuckanut parking lot!

cars until 10:00 a.m.), it is especially suited to folks who have difficulty walking on rugged trails. The first half mile is level, so anyone with limited mobility or in a wheelchair is invited to join the group for this part of the walk. The loop road runs through fir forests along the edge of Guemes Channel and Burrows Channel, providing opportunities to view the sea birds with our scopes (Pigeon Guillemots, Cormorants, Marbled Murrelets, Black Oystercatchers, Harlequin Ducks, Great Blue Herons, various Gulls, Surf Scoters, Red-necked Grebes, and others are likely) - as well as the various Sparrows, Wrens, Chickadees, Kinglets, Woodpeckers and other forest birds. We'll meet at 8:30 in the parking area near the restrooms (just past the boat trailer lot, near the beginning of the one-way loop road). We'll walk the road slowly (a little over 2 miles) and we'll stop along the water's edge. The walk may very well end by 11:00 a.m., depending on sightings and desires. To get to Washington Park, follow the San Juan Ferry signs through Anacortes (at the roundabout go north on Commercial to 12<sup>th</sup> St., then west on 12<sup>th</sup> St., which becomes Oakes Avenue). # New Safeguards for West Coast Forage Fish Local Seabirds, Marine Mammals and Fish to Benefit By Trina Bayard, Ph. D., Director of Bird Conservation, Audubon Washington

The future for our west coast marine life just got a little more secure. On Tuesday, March 10, the Pacific Fisheries Management Council approved new protections for forage fish species, a move that signals a shift towards a more ecosystem-based approach to fisheries management.

The Council is responsible for managing fish stocks in federal waters (3-300 miles) offWashington, Oregon, and California and has been working to develop protective measures for unregulated forage species over the past three years.

Forage fish are increasingly in the limelight for the critical role they play in supporting the marine food web, as well as the rising global demand for fish meal and fish oil. The Council's action takes a precautionary approach to forage management. New fisheries must first demonstrate that harvest will not harm the ecosystem before they are approved. Although some well-known forage species such as anchovy and sardine are managed through existing fishery management plans, many other species, including sand lance, smelt, and pelagic squid, are not.

Among the seabirds that will benefit in Washington state are the Tufted Puffin, which is currently being considered for listing as a state endangered species; the Marbled Murrelet, a state endangered seabird which feed its young with sand lance and smelt; and various auklet and storm petrel species, which feed on a wide variety of forage species. Dozens of other visiting and resident species also rely on forage species.

"Our marine birds face enormous risks," said Gail Gatton, Executive Director of Audubon Washington, "including ocean acidification, habitat loss, oil spills, and climate change. We're thrilled that the Council took

action to tackle at least one of the threats these birds are facing – diminished supplies of their major food source."

Trina Bayard, Director of Bird Conservation at Audubon Washington, called the Council's decision a win for birds, fish, and people alike. "Forage species are the bread and butter of the marine world, providing food not just for marine birds like the Tufted Puffin and the Western Grebe, but for economically important fish such as salmon and lingcod. The Council has taken an important step to ensure that forage species, and the human, wildlife, and economic values that they support, can be sustained for generations to come."

# **Join the Heron Study Team**

For the second year, volunteers are gathering data about where and how Great Blue Herons forage, rest, and nest on and around Skagit County's bays. Information collected last year about this iconic and important species has already proven valuable. Participating need not involve many hours or days.


