Pursuing the Mystery of the Marbled Murrelet by Maria Mudd Ruth

Marbled Murrelet

Maria Mudd Ruth calls herself an accidental naturalist. She is the author of more than a dozen books on natural history topics for both young readers and general audiences. Her published work includes books about ecosystems of North America: *The Pacific Coast, The Tundra, The Southwest Deserts, The Mississippi River*. Maria's range of subjects reflects her interest in restoring our awe in the natural world. She is an active citizen scientist and has been surveying Oregon Spotted Frogs and Pigeon Guillemots.

Maria will present her work on Marbled Murrelets: *Rare Bird: Pursuing the Mystery of the Marbled Murrelet*. Alcid nests are typically found on ledges and in burrows on rocky outcrops and coastal bluffs near the water's edge. The Marbled Murrelet is not your typical alcid. It is unique in its choice of nesting sites. During the summer breeding season, the Marbled Murrelet flies well inland to nest in trees. And not just any trees, but the large-limbed ancient conifers of the mature and old-growth coastal forests. In these trees, the Murrelet finds high, wide, mossy platforms where it can make its web-footed landing, lay and incubate its one egg, and feed its chick until it fledges. During its time in the forests, this Murrelet is camouflaged, silent, and secretive; its nest, egg, and chick are well hidden. They are central to the controversy regarding logging old growth.

Join us as we learn from Maria the secrets of the Marbled Murrelet.

SKAGIT AUDUBON FEBRUARY CONSERVATION REPORT By TIM MANNS, CONSERVATION CHAIR

At this writing in mid-January, the Washington Legislature is just 4 days into its 60-day session. The focus is on meeting the constitutional and court mandate for funding education and a number of other pressing issues. Audubon Washington continues to participate with over 20 other organizations in the Environmental Priorities Coalition (EPC). This year EPC has chosen one environmental priority – *Safeguard Our Environment* – and is focused on protecting our natural resources including clean air, clean energy, clean and abundant water, and healthy public lands against any roll back of environmental protections. Jen Syrowitz, (jsyrowitz@audubon.org), Washington's Audubon Chapter Conservation Manager, can also add you to her list for legislative updates and action alerts.

As mentioned in the January *Skagit Flyer*, Audubon Washington is also trying to initiate movement towards implementing the resolution Skagit Audubon submitted last fall to reform how the Forest Practices Act addresses logging in urban areas. Audubon's advocate, Neil Beaver, has been active in meeting with legislators and with relevant organizations such as the Association of Washington Cities and the Washington Forest Protection Association. We hope the work being done during this short legislative session will lay the groundwork for decisive movement in 2017.

The Washington Department of Ecology (DOE) recently issued its draft Clean Air Rule prepared at Governor Inslee's direction under the state's Clean Air Act. This rule will cap and gradually reduce emissions of carbon dioxide and other greenhouse gases by the companies and institutions emitting over 60% of these emissions in Washington. Read DOE's clear explanation of the rule and submit comments at http://www.ecy.wa.gov/climatechange/carbonlimit.htm. This is Washington's first-ever rule capping carbon pollution and seeking to slow climate change effects. Recall that National Audubon's science staff has done large scale studies of what climate change means for North American birds. If you haven't already done so, have a look at http://climate.audubon.org/.

Last year the Anacortes City Council revised the city's animal ordinance without addressing the issue of free-roaming cats. Reiterating a statement from the November 2015 *Skagit Flyer:* Studies by the Smithsonian Institution and the U.S. Fish & Wildlife Service show that free-roaming cats in the U.S. kill approximately 2.4 billion birds every year (http://abcbirds.org/program/cats-indoors/cats-and-birds/). Anacortes has not yet done as many other municipalities in the U.S. and moved towards regulating cats just as dogs are restricted in their wandering. Residents who would like to see further amendments to the animal ordinance should contact city council members and the mayor, keep an eye on council meeting agendas on-line, and attend council meetings.

STUDENTS LEARN ABOUT EAGLES AND DDT

Jean Ashby, of the Audubon Skagit Education Committee, and Ron Holmes, a Skagit Audubon member - photographer, did a great job of keeping the Kulshan Creek kids, both elementary and junior-high school, engaged and interested in the lesson about Bald Eagles and their role in the food chain. They explained how DDT entered the food chain and nearly wiped out Eagles, Brown Pelicans, and Osprey in the 1950's, 1960's and 1970's. Ancient history for these kids! They learned how the Bald Eagles shift from salmon carcasses to live ducks and other prey like small mammals, when the salmon carcasses are no longer available. It was a fine day of learning in the great out of doors!

SKAGIT AUDUBON HIKING ~ FEBRUARY

Winter hiking will continue with four hikes. Unexpected circumstances such as weather, wash-outs, closed trails, logging, construction, or road conditions may cause cancellations or changes in the following hikes. A hike will be canceled if there are high wind warnings, flooding conditions, snowy or icy road conditions, or forecasts of continued rain. All the hikes are on a Wednesday. Dogs are discouraged on Audubon-sponsored hikes. If dogs are on a hike, they must be on a leash at all times. Questions? **Contact Joan Melcher: 360-424-0407** or **jdmelcher@comcast.net**

WED. FEB. 3 – WHATCOM FALLS & CREEK, BIG ROCK LOOP, & THE STIMPSON FAMILY NATURE PRESERVE – a number of options

I. Whatcom Falls & Creek: Hike along Whatcom Creek from Whatcom Falls Park to the I-5 Freeway bridge and back. It is a 4.4 miles round trip with a slight elevation gain. Leave when you return to your car.

II. BIG ROCK LOOP: Instead of or in addition to the Whatcom Falls & Creek hike, do this hike. It is a 6 mile loop that begins and ends at Whatcom Falls Park. This loop takes the hiker north with some ups and downs, and a few short, steep sections. The hike is mostly road walking, with some sidewalk.

III. STIMPSON FAMILY NATURE PRESERVE:

If you wish to do this hike after **I**, **II**, or **both of those above**, then drive to the Stimpson Family Nature Preserve and hike up to 4 miles there with about a 400 ft. elevation gain.

For all of the above, meet at 8:30 a.m. at the I-5/ Chuckanut Drive Park-n-Ride near exit 231 from I-5 **OR** meet at 9 a.m. at the Whatcom Falls Park parking lot on Arbor Street off Electric Avenue. Ride with those who plan to do the hike(s) you wish to do. When all return to your car, you may leave.

WED. FEB. 10 - LUMMI ISLAND

Walk a 7 mile loop on the north end of Lummi Island and enjoy island, sea, and mountain views. A \$7 foot-passenger ferry fare is required. The hike is mostly level. Walking shoes are recommended. Meet at 8:30 a.m. at. the Chuckanut Drive Park-n-Ride, exit 231 from I-5 on the east side of I-5. There is no specified return time, although most will take the 1 p.m. ferry back.

WED. FEB. 17 – CAMANO ISLAND

Friends of Camano Island Parks, FOCIP, will lead us on hikes on Camano Island. These hikes are up to 11.9 miles with shorter options available. Lunch is provided with a suggested donation of \$2. Meet at 7:45 a.m. in the S.E. corner of the Mount Vernon

Safeway parking lot or at **8:30 a.m.** at the Blue Camano Center Building on East Camano Drive. There will be a brief orientation there. Hike options will be discussed. Maps will be given out. Restrooms will be available.

A Discover Pass is required in either Cama State Park or Camano Island State Park.

WED. FEB. 24 – CONWAY-AREA DIKE

The dike, on the east side of the WALK Skagit River north of Conway, is now open for public use. The hike is 3.3 miles one-way and then back. Meet at 9 a.m. in the parking area described below. You may leave when you return to your vehicle. Lunch, if you like, at the Conway Pub & Eatery. If the weather is clear there will be great views. Birds should be plentiful. From I-5 take exit 221 which is signposted Conway and Lake McMurray. This is also the Pioneer Hwy (SR 534) which leads to Stanwood. Turn west toward Conway/Stanwood and very shortly (100 yards) turn right on Fir Island Road into Conway. Go over the rail road tracks and in 100 yards turn right on Dike Road just before the bridge. Do not go over the South Fork of the Skagit River Bridge onto Fir Island! Parking is available on the left in 200 yards, north of the unsigned dike district building.

WED. MARCH 2 – LILY LIZARD LAKES LOOP (THE LLLL)

This Loop will be done in a clock-wise order. On Blanchard Mountain hike the Lily Lake, Larry Reed, and Max's Shortcut Trails to Lily Lake and then on to Lizard Lake by way of a connector trail from the North Butte Trail. Return to trail head via the Lizard and Lily Lake Trails. The loop is 8.6 miles with a 1,600 ft. total elevation gain. There is an opportunity to go to the Oyster Dome and the North Butte as well. We will divide into a faster and slower group. Car pool accordingly. Meet at 8:30 a.m. at the Chuckanut Drive Park-n-Ride, exit 231 from I-5 on the east side of I-5.A 2:00 p.m. return to the trailhead for the faster group; 3 p.m. for the slower group. **Discover Pass is required to park!**

Saturday, February 13 Johnson DeBay Swan Reserve and other Clear Lake & Burlington sites 3:00 p.m.to 6:00p.m.

The Washington Department of Fish & Wildlife's Johnson DeBay Swan Reserve is the only place in the U.S. specifically set aside for swans. In winter, our home area hosts Tundra Swans and the largest concentration of Trumpeter Swans in the world. Seeing hundreds of this largest North America waterfowl in one place is among the Skagit's greatest avian wonders. On this field trip we'll visit the reserve and some other sites near Clear Lake and Burlington, looking for waterfowl, raptors, and upland species too. Swans mostly use the reserve as a night roost, so we'll be there at dusk in hopes of seeing and/or hearing the great white birds fly in for the night. Dress for the weather. Bring binoculars and, if you have one, a spotting scope. A WA State Discover Pass is required for parking at the reserve. Meet in the PETCO parking lot in Mount Vernon off College Way just east of I-5 Exit 227. We'll form carpools there. (For information about swans in Washington, go to http://nwswans.org/


Saturday, February 20 South Fidalgo Island and Deception Pass State Park 8:30 a.m. to 12 noon
